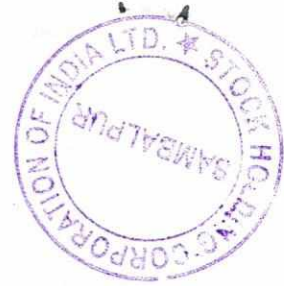

- i. Have powers to appoint such persons on such terms and conditions as it deemed fit for conducting studies, research, investigation, teaching or any such work undertaken by the Trust.

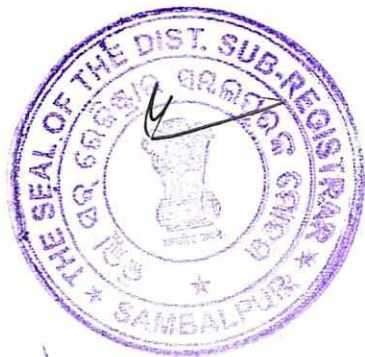

- o. Have powers to appoint committee or sub-committees or societies for such purpose and with such powers as the Board of Trustees may think proper.
- p. Have powers to appoint Advisory Boards, Examining Body, Expert Committee or such Committee consisting of Members who may/may not be member of the Trust with such advisory powers and functions as the Board of Trustees may think it proper .

#### 5. MEETING OF THE BOARD OF TRUSTEES

purpose and signed by the Chairman of such meeting or of the following meeting.

- (f) The meeting of the Board shall be called by the the Chairman in consultation with the Trustees, In the absence of the Chairman any other member of the Trust can convene the meeting with the prior intimation to the Chairman.
- (g) The Trustees shall keep or cause to be kept proper account of all members received and disbursed or spent for the objects and purposes of the trust.
- (h) The Trustees will appoint a Chartered Accountant as the Auditor of the Trust to conduct the audit of the account of the Trust every year.

Without affecting the generality of powers and functions of the trustees to manage and administer the trust, the Board of trustees shall have the following functions:

- i. The Chairman shall be the Head of the trust with powers of overall control and supervision over the affairs of the Trust. He shall preside at every meeting of the Managing Committee, and of all Committees and Sub-Committees. He shall preside at all meetings.. He shall control the working of the staff of the Trust and direct, supervise and take necessary action in all matters of the Trust. - ii. In the case of necessity or emergency, he shall do all the acts that are necessary and deem fit for the objects and safe guarding the interests of the trust.
- iii. To borrow if needed, against the security of the assets of the trust by way of bank over drafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision of agreement and to authorize two or more of the trustees to execute such documents, deeds, papers, etc. as may be necessary in connection therewith.

terms and conditions, rules and regulations as the Board of Trustees may from time to time think fit and proper.

- vii. To spend any portion of the corpus or the income of the trust fund for purchasing any land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and/or executing any or all of the objects of the trust duly approved in the Trust Board Meeting.
- viii. The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management for trust properties or in relation to the carrying out of the objects and purpose of the trust as well as of all the assets, credits and effects of the trust properties.
- ix. The trustees may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in Sub-sec-3 of Sec-13 of Income Tax Act, 1961, or any subsequent amendments as may be made from time to time.
- x. If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the years and spent in such subsequent year or years for the advancement of any of the object of the trust.
